All Vendors-Exhibitors will be introduced at the Friday evening opening ceremony. All are invited to keep their space open until Sunday at 1:00PM. We must have break down and clean up of the vendor area complete by 5:00 pm on Sunday, no exceptions.

The Sedona Creative Life Center will charge a 5 percent fee on all sales. However, there is no tax or vendor license necessary at the Center. Travel and hotel arrangements are the responsibility of each Vendor-Exhibitor. Please check the Gathering web site for area hotels offering special Gathering Rates.
